Madrid, 8 de Agosto de 2017: A EDP Renováveis, S.A. ("EDPR") vem prestar a seguinte informação ao mercado e ao público em geral:

A EDP – Energias de Portugal S.A. ("EDP") comunicou à EDPR que detém uma participação qualificada, nos termos do artigo 23.º do Real Decreto 1362/2007, composta por 720.191.372 acções, representativas de 82,56% do capital social da EDPR e 82,56% dos respectivos direitos de voto.

O aumento da participação qualificada da EDP para 82,56% resultou da aquisição, a 8 de Agosto de 2017, de 43.907.516 acções, que correspondem a 5,03% capital e respectivos direitos de voto, no processo de Oferta Pública Voluntária para a aquisição das acções representativas do capital social da EDPR.
